**Gary Gensler** served as the Chair of the US Securities and Exchange Commission (SEC) until January 2025. Currently, he is Professor of the Practice at the MIT Sloan School of Management, where he teaches and researches artificial intelligence and financial technology, among other topics. Gensler has held numerous responsible positions in public service. At the beginning of his career, he spent 18 years at Goldman Sachs, ultimately as a partner.



**Dr Stephan Leithner** has been CEO of Deutsche Börse AG since 2025 and has been on its Executive Board since 2018. Previously, he worked as a partner at EQT and in leadership positions at Deutsche Bank AG, including three years as a member of the Executive Board. He was a partner at McKinsey & Company and began his professional career at the Swiss Institute of Banking and Finance at the University of St. Gallen.
